### **Measuring Audiences**

The only information we collect from a normal web site visit is the name of your internet service provider, the browser and type of machine you are using, the pages you request and the date and time you request them and the web site that referred you to us. #### **IP Address**

The World Parrot Trust may collect email addresses and other personally identifiable data about visitors when such data is voluntarily submitted to www.parrots.org or its related sites. We collect, use and disclose personal information only for purposes that a reasonable person would consider appropriate. Regularly, our members are given opportunities to choose how often and in what way they wish to hear from us. At any time, our supporters are able to opt out of receiving communication material.

World Parrot Trust strongly observes anti-SPAM and GDPR practices in its email outreach programs.
